Re: Recreation Center Usage Request – *Boogie Down Roller Rink*

BACKGROUND

Included with this report is a letter from Lawrence E. Follie Jr. of Mosinee whom is requesting approval to use the Recreation Center on weekends during the summer for the “*Boogie Down Roller Rink*”.

As indicated within the letter, Mr. Follie is planning that the rink would be open from 11:30 a.m. to 11:30 p.m. The admission cost would be \$5.00 and the skate rental cost would be \$1.50. Mr. Follie also plans to sell various typical concession items.

Mr. Follie indicates that the purpose of the roller rink is to “*give children in our community something to do close to home*”.

DISCUSSION

The Commission should establish the following with respect to the Recreation Center facility usage request for the purposed *Boogie Down Roller Rink*:

- Facility Usage Merits
- Facility Usage Dates
- Facility Usage Hours
- Facility Usage Security Requirements
- Facility Usage Rental Fees

STAFF COMMENTS

Staff would like to point out that the City’s curfew requirements do not permit a child under the age of sixteen (16) in a public place after 10:00 p.m., unless they are accompanied by a parent or guardian.

The City’s Recreation Center usage fees for a profit-making event are currently \$400 for a half/day and \$800 for a full day. The Commission does have the ability to adjust the fees for a specific event.

Should the Commission determine that the proposed Recreation Center usage request is acceptable, staff would like to respectfully suggest that the Commission consider including the following facility usage requirements:

1. That the applicant sign a Recreation Center Usage Agreement; and
2. That the applicant submit a Certificate of Liability & Workers Compensation Insurance Coverage Policy which includes the City's standard policy coverage levels and lists the City as additionally insured; and
3. That the applicant submit a Marathon County Health Department food license or written confirmation from the Health Department that a food license is not required; and
4. That the applicant also successfully pass a standard City background check, as the commercial use of the public facility involves children.

COMMISSION ACTION REQUESTED

The Commission's consideration of Mr. Follie's request to utilize the Recreation Center for the "*Boogie Down Roller Rink*", is requested at this time.
